Why the New Name? Welcome to Think Dignity, formerly Girls Think Tank. Over the course of the following months you will notice a few changes, including: a new website, a new brand, as well as our new name. You will also notice an updated tagline and mission, which more adequately reflects who we are, what we do, and the community we serve. We love our new name because it speaks to our mission and foundation, which has always focused on advancing basic dignity for those living on the streets. Think Dignity is a reflection of our values and mission, and is not exclusive on its face. Our new name invites everyone to be a part of our organization.

#### **Transitional Storage Center**

(TSC): We are pleased to announce we have 304 new lockers at the TSC. These lockers provide additional dignity to those we serve, and with both lockers and bins, we will now be able to serve about 400 clients total. This increases our capacity since last year by over 100 individuals!

The lockers were made possible due to the *generous* support of the San Diego Housing Commission and City of San Diego; Sudberry Properties, Inc. (who Think Dignity is excited to have as a 3-year funding partner); Duckett-Wilson Development Company; as well as other private donors. See all the action from installation day here.

We are also happy to announce our partnership with San Diego's Downtown Partnership, which allows the collection of unattended property to be safely stored in a dignified manner.

The TSC is a win-win for downtown residents, business owners, the City of San Diego, and those who are experiencing homelessness by allowing individuals a safe space to store their items, thereby clearing the sidewalks of downtown of over 30,000 lbs. of belongings.

From March-October 2015 we have served 482 clients. Of those, 115 transitioned out of the Center due to a positive change in circumstance, including employment and housing. 126 of our clients were women and 46 were Veterans. 228 of these individuals were living in places not meant for habitation, with 59 staying in an emergency shelter, and 62 in transitional housing.

## Community Legal Education Workshops:

GTT started quarterly Community Legal Education Workshops in 2014 and since then have provided Workshops on Military Discharge Upgrades, Expungement of Criminal Records, Prop 47 Felony Reductions, Restraining Orders, and laws related to sleeping on the streets. These Workshops provide those on the streets with an opportunity to learn more about specific areas of the law that most affect them from attorney's who specialize in those areas. The Workshops were made possible, in part, by a grant from the San Diego County Bar Foundation.

### Legal Referral & Advocacy Clinics:

This year led to expansions in Think Dignity's mobile Legal Referral and Advocacy Clinic. We have grown from providing aid at three locations to five locations.

We are excited to help out at our new Clinic locations: monthly at Monarch School for Homeless youth and bi-monthly clinics to clients of the San Diego Rescue Mission. Think Dignity Clinics provide much-needed aid to those living on the streets in order to help them resolve their legal issues and overcome hurdles surrounding these issues.

The expansion of the Clinics was made possible, in part, by a grant from the San Diego County Bar Foundation.

Think Dignity began quarterly East Village Clean-Ups last year to show we take pride in our community. Since starting these cleanups, we have expanded our reach by partnering with the Clean-Ups of the Downtown Fellowship of Churches & Ministries in their "Doing It Better Together" efforts.

Think Dignity is excited to announce that the Park and Market Loo is operating successfully. While there have been challenges at the 14th and L Street location, we are happy to report that both locations are currently operating.
